COVID-19 DISASTER ACT REGULATIONS

The indemnitee agrees to the following regulations in line with the Disaster Management Act Regulations Level 1 and The Island Beach Bar to minimise the spread of COVID-19.

I hereby agree to coming to the **Island Beach Bar** In consideration of your acceptance of my application. I hereby indemnify, absolve, exempt and release all sponsors, their members and agents and any officials connected with the event against and from any or all claims whatsoever and from liability for injuries, damage or death arising from or in connection with my participation in, travelling to or from, or in the presence of the **Island Beach**, and I waive any and all claims whatsoever which I may have arising therefrom or in connection therewith. I authorise the use of photographs, moving pictures and internet images taken at the event of the Island Beach Bar Opening, without payment, therefore I agree to co-operate with all sponsors in the promotion of their products.

I further acknowledge that the Island Beach Bar has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.

I further acknowledge that the **Isand Beach Bar** can not guarantee that I will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/ or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, salon staff, and other salon clients and their families.

I voluntarily seek services provided by the **Island Beach Bar** and acknowledge that I am

increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread while attending the Island Beach Day Opening.

In accordance to the Disaster Management Act: Regulations: Alert Level 1 during Coronavirus COVID-19, I will adhere to the following regulations when attending **Island Beach** in order to limit exposure to COVID -19. This is in accordance to the **Disaster Act 2002: AMENDMENT OF REGULATIONS ISSUED IN TERMS OF SECTION 27(2).** I attest that:

- I acknowledge the contagious nature of the Coronavirus/COVID-19 and that the South African
 Health Department and many other public health authorities recommend practicing social
 distancing and maintaining a distance of least one and a half metres from each other; and
 adhere to any other health protocols and social distancing measures provided. This includes
 and not limited too wearing a face mask; hand santising regularly, avoid transmitting saliva,
 touching my face where necessary.
- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within the South Africa in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by the state or local public health authorities.
- I am following all South African Health Department recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I hereby release and agree to hold **Island Beach Bar** harmless from, and waive on behalf of myself and any personal representatives from any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with any services received from **Island Beach Bar**.

I understand that this release discharges **Island Beach Bar** from any liability or claim that I or any personal representatives may have against **Island Beach Bar** with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from **Island Beach Bar**. This liability waiver and release extends to all owners, partners, and employees.

I hereby indemnify, absolve, exempt and release all sponsors, their members and agents and any officials connected with the event against and from any or all claims associated with COVID-19. Participation of all **Island Beach Bar Events** are entirely at your own risk. The organisers, sponsors & venue hold no responsibility whatsoever.
